

** 2006 TGA Membership Renewal **

Dear TGA members:

Below is your renewal form for the calendar year of 2006. In an effort to save on costs "These will not be mailed" this year. Each member (regular, Grandfathered and Lifetime) should fill this form out and return it to the TGA offices with the appropriate renewal fee, no later than January 1, 2006 to avoid any lapse in your membership.

We have added credit card services to our organization. Visa and MasterCard are accepted if you would like to charge your renewal fee to it.

Membership (Voting & Non-Voting) Renewal Fee = \$25
Associate Membership Renewal = \$100
Lifetime Renewal Fee = \$-0-
Grandfather Renewal Fee (Unless Lifetime status has been reached) = \$25

ARTICLE II; MEMBERSHIP; SECTION 1.MEMBERSHIP; A. VOTING MEMBER: A voting member must be a voting member in good standing with the National Greyhound Association; must reside in the state of Texas; must have registered one or more greyhounds with NGA; and, must have been a member of TGA for at least 60 days in order to have voting rights. Each voting member shall be entitled to one vote.

SECTION 6. ANNUAL DUES: Membership dues shall be established by the Executive Committee and are due and payable on, or before, the first day of January of each year.

SECTION 8. DELINQUENCY AND CANCELLATION: The Executive Committee shall have the power to suspend or revoke the membership of any member, in accordance with Article IV Section 13 of these by-laws. Any member of the Association who has not paid his/her dues by January 1st of each year shall be notified of such delinquency. If payment of dues is not made by March 1st of each year, the delinquent member shall be dropped from the rolls and thereupon forfeit all rights and privileges of membership, unless such suspension, at the request of the member, is waived by affirmative action of the Executive Committee.

SECTION 9. REINSTATEMENT: A former member, whose membership lapsed due to non-payment of dues by March first, may be reinstated upon proof of qualification and payment of initiation fee and annual dues.

SECTION 10. CHANGE OF ADDRESS: Members shall notify the Association of any change of address within 30 days after such change. Any Voting Member who moves out of the state shall become a Non-Voting Member for the remainder of that year, and may apply for Voting Membership at such time his/her residence is reestablished in Texas.

Any business or corporation. One person shall be designated to represent the business or corporation.
- LIFETIME MEMBER (Must apply/renew annually) ANNUAL FEE NONE**
Must have been a voting member of TGA for ten (10) consecutive years; must be 65 years old or older. Current Lifetime Members need only to check the box. If applying for Lifetime Membership for the first time, fill in the blanks below.
